Victoria's Simply Dancing Policies

I understand that this contract with Victoria's Simply Dancing, in its entirety, cannot be contested in a court of law. My electronic signature below is verification of my understanding of this contract in its entirety.

School Registration & Tuition Policy:

The registration fee and first month's tuition are due upon the registering of classes via at the studio or via on-line (ZOOM). The registration fee is annual and must be paid at the beginning of every dance season. The tuition is due by the 1ST of the month; REGARDLESS of absence the week tuition is due. The registration, tuition, missed classes, and any other fees are non-refundable and non-transferable.

Methods of accepted payments are CASH, CHECK, and/or credit/bank card with the VISA/MASTERCARD logo. A valid and current bank/credit card is required on file at all times. Victoria's Simply Dancing has permission to charge my bank/credit card for tuition on the 1st day of each month if on auto pay; and/or if NOT on auto pay any unpaid/outstanding tuition after the 5th day of each month will be charged automatically with a \$20 late fee. There is a \$25 fee for insufficient funds, returned checks, and/or declined bank/credit cards on any outstanding debt.

I authorize Victoria's Simply Dancing to charge the credit card on file for all charges posted to my account.

School Recital & Costume Policy:

All recitals have a separate commitment contract and are available, approximately, in October & April of each year.

Photography & Video Taping Policy:

I grant permission to Victoria's Simply Dancing to use photos and videos of my child for advertising and publicity purposes, inclusive of print advertising, educational videos, television, videotaping or film broadcast in connection with promotional campaigns. I understand that my child might be videotaped/photographed by spectators.

School Medical Insurance Policy:

It is required that all students be covered by their own family insurance policies. If injury occurs, it is understood that the student's own policy is the only source of reimbursement. I recognize that participation in this activity has a certain amount of risk and that injury is always possible. I understand that in case of emergency, when medically feasible, an effort will be made to contact a parent/guardian, but in the event, one cannot be reached or it is not medically feasible to contact one, I give consent to the staff to act on my behalf. I (we), the undersigned, release the teachers, staff, and Director/Owner of Victoria's Simply Dancing from any and all claims for damages and injuries my child may sustain while participating.

School Dress Code:

I understand that required dance wear and dance shoes must be worn in class at all times. Examples: Ballet Shoes/Jazz Shoes/Tap Shoes/Half Soles/Non-Marking Sneakers. Hair must be worn up and away from the face and neck. A bun is required for all ballet classes. The studio is NOT responsible for providing dancers with required dancewear.

Attendance/Enrollment & Account Deactivation Policy

All accounts are active until the parent/guardian notifies the studio in person or by the email from the email address on file here at the studio. We will consider a refund on tuition for anyone who cancels by the 5th of the month AND has not attended classes for the month. All requests for inactivating an account made after the 5th of the month will not receive a refund for any paid charges. Victoria's Simply Dancing reserves the right to have students who arrive more than 10 minutes late to a class, sit out of class. Make-up classes can be taken within 30 days from the day the class is missed. Inactive students cannot make-up missed classes and missed classes cannot carry over to a new dance session. The dance schedule is subject to change at any time and notice will be posted if changes are made. All accounts will continue to be billed for monthly tuition until a Withdrawal Notice is submitted to the studio and no refunds will be issued prior to the date of the written notification and must be made prior to the 5th day of the month. All scheduled private lessons that are cancelled less than 24 hours prior to the scheduled time will be charged a, non-refundable, \$15 cancellation fee. All children are to be supervised by their parent/guardian at all times before and after their dance class(es). Victoria's Simply Dancing is not responsible for unattended children inside the lobby, empty studio room or outside the premises. Any open charges on an account must be paid prior to inactivating.

We reserve the right to refuse service to anyone.

Service During Pandemic Notification Agreement

I verify that I, the account holder, am the legal parent/guardian of my child(ren) on my account. I, the legal parent/guardian of the above-mentioned child(ren), knowingly and willingly consent to have dance lessons taught to my child(ren) during the COVID-19 pandemic. I understand the COVID19 virus has a long incubation period during which carriers of the virus may not show symptoms and may still be highly contagious. It is important to determine who has it and who does not, given the current limits in virus testing. To prevent the spread of the contagious viruses and to help protect each other, I understand and will follow the studio guidelines. I understand that air travel increases the risk of contracting and transmitting the COVID19 virus. I verify that I will notify the front desk staff at Victoria's Simply Dancing IMMEDIATELY should I, my dancer, or anyone in my household who has traveled outside the United States or domestically during the pandemic. I verify that I will not bring my dancer to the studio for dance lessons should I, or anyone in my family travels for any reason and will not return to lessons until I have quarantined for 14 days. I affirm that I will notify Victoria's Simply Dancing should I, my dancer, , as well as all members of my household, if they have been diagnosed with COVID19 and I will confirm that I, my dancer and anyone in my household has self-quarantined for 14 days. I affirm that I, my child(ren), as well as all members of my household, have not knowingly been exposed to anyone diagnosed with COVID19. I affirm that I, my child(ren) and any member of my household who is present at the dance studio will enter with a mask on. I understand that should I not have a mask I will not be permitted to enter our lobby. By signing below, you agree to each statement and release Victoria's Simply Dancing, the VSD Choreographers, Desk Staff & their families from any and all liability for unintentional exposure or harm due to COVID19.

I confirm that I, my child(ren), nor anyone in my household, are not presenting any of the following symptoms of COVID19 or the FLU and am willing to have my temperature taken as well as my child(ren) every time I bring my child(ren) to dance lessons at the studio. Fever/Chills *temperature of 99.1 or higher,-Shortness of Breath/Difficulty Breathing, Loss of Taste or Smell, Muscle Pains, Dry Cough/Sore Throat, Loose Cough with Phlegm, Runny Nose, Rash, Vomiting, Diarrhea. Victoria's Simply Dancing affirms that we have improved and expanded our sanitation protocols to fight the spread of germs more thoroughly.

I have read, understand, acknowledge, and support the above and I agree to abide by all VSD policies including the Cancellation Requests Policy, and Service During Pandemic Notification Agreement.
